The 17th Century Country Estate of William Penn

Pennsbury Manor is the 17th century recreated country estate of William Penn, statesman, founder and first governor of Pennsylvania. It is situated on 43 acres along the Delaware River in picturesque Bucks County. Originally built in 1682, the estate closely reflects the 40 acres Penn himself had cleared. Today, Pennsbury Manor is administered by the Pennsylvania Historical and Museum Commission with the Pennsbury Society, a non-profit 501(c)(3) organization. Through tours, exhibits, workshops, and educational programs, Pennsbury shares the 17th century and the life of William Penn with over 30,000+ visitors each year.

Pennsbury Manor was among the first to receive full accreditation of the 11 historic sites and museums in Pennsylvania currently accredited by the American Association of Museums.


